GWINNETT COUNTY BOARD OF ASSESSORS October 20, 2021

The regularly scheduled meeting of the Gwinnett County Board of Assessors took place Wednesday, October 20, 2021, at 9:00 am. Those in attendance were Johnny Blan, Chairman; Burt Manning, Vice-Chairman; Norman Ellis, Assessor; Sharyl White, Assessor; Mark Cooper, Assessor; Nathan Woods, County Attorney; Stewart Oliver, Chief Appraiser and Ginger Roderick, Recording Secretary.

Chairman Blan called the meeting to order and asked for approval of the agenda. Mr. Cooper made a motion to approve the agenda. Ms. White seconded and so carried unanimously.

The Board reviewed the minutes of the October 6, 2021, regular meeting. Chairman Blan asked if there were any corrections or additions to be made. Vice-Chairman Manning made a motion to approve the minutes. Ms. White seconded and so carried unanimously.

Next under Old Business was Value Update. Appeals exist for the current and prior years. There is three from 2019, 56 from 2020 and 1,471 open appeals for 2021. Overall, the appeals continue to progress. Mr. Oliver shared information to the Board that was presented to those in attendance at the GAAO Fall Seminar. Mr. Alcock Shared with the Board updates for 2<sup>nd</sup> quarter of 2021 on Hotels, Apartments and Warehouses.

Under Other Business, Chairman Blan asked if there were any Administrative and Policy Updates. Mr. Oliver announced that one appraiser has been filled internally; the other position has received conditional job offer through Human Resources. We received a resignation from Ava Dupree who has announced her retirement and will be leaving us on 10/29/21. There will now be two ASA II positions vacant in Taxpayer Services.

Chairman Blan asked if there was any other business to be discussed. There being none, Mr. Ellis made the motion to adjourn. Ms. White seconded and so carried unanimously.
