4. Old Business

- a. Legal Opinion: The Board reaffirmed that at the previous meeting, they had agreed to maintain the existing policy of requiring a recorded deed for the change of ownership records. Additionally, it was confirmed that a new process was enacted to provide owners with specific property and deed record information that will assist them in searching for recent deed activity in the Recorder's Court. There was also a discussion of whether Mr. Wood had acted on the authority to subpoena records to resolve an outstanding personal property matter. Mr. Wood advised the Board that the property owner was made aware of the Board of Assessors' subpoena power, but he has not acted upon that authority at this time. A meeting would take place with the property owner and is expected to produce documents responsive to the Board's needs.
- b. Value Update: Mr. Oliver informed the Board regarding the current state of 2022 digest year appeals. As of now, 0.01% of the 2022 gross digest (not including public utility values) remains in dispute. There are 14,828 of the 14,834 total appeals that are now closed. Regarding 2023 digest year appeals, 21,248 of the 21,530 total appeals are now closed. This is 0.24% of the digest (not including public utility values). Mr. Alcock presented the Commercial Market update.
