Q1: Can you please provide the previous tabulation?

Q2: Is it acceptable to bid on only the line items we feel we could offer competitive pricing?

Gwinnett County reserves the right to reject any or all bids to waive technicalities and to make an award deemed in its best interest. Bids may be split or awarded in entirety.
