Q1. In regards to addendum 2, "Q46, a." regarding the Base Award form. The County says: "It should be the Fee Schedule for Task Orders and Fee Schedule for Supplemental Staff on this one. There is no base award to give." Does that mean firms do not need to include the "Proposal Fee Schedule – Base Award & Renewal Option" form (RP page 18)?

A1. Firms need to include all Fee Pages from 16-18.

Q2. May we assume the Subcontractors do not need to submit the Non-Collusion form?

A2. Subcontractors do not need to submit the Non-Collusion form.

Q3. Per Answer addendum 2, question 6, you also asked that subconsultants complete the FTA Clauses in the invitation (page s 52-66). Is "Clarification 1: Additional Federal Requirements," part of the FTA Clauses information that should be returned in whole by subconsultants and the prime per Answer 37?

A3. Yes, the Additional Federal Requirement provided in addendum 2, should be submitted with the other clauses. ALL primes and Subs that are part of the proposal are required to submit signed FTA Clauses.
