2. All prices shall be *FOB Destination Pre-Paid and Allowed* to various county delivery addresses.

Page 2, item II.G. add the following to this requirement:

*Samples should be delivered no later than five business days from request.*

Page 2, item H change to read as follows:

H. Invoices: Successful suppliers for Phosphate Corrosion Inhibitor and Liquid Magnesium Hydroxide must submit invoices at the unit price bid with the signed receipt tickets showing the accurate weight received. All invoices must show date received, Gwinnett County order number and the Gwinnett County bid number.

Page 18, Bid Schedule

The pricing structure has been changed back to a per gallon cost which replaces the % markup. Replace Page 18 with attached page 18R
