- C3.** See the BL140-23 plan holders list from October 27, 2023. This list is included as an Attachment to this Addendum.

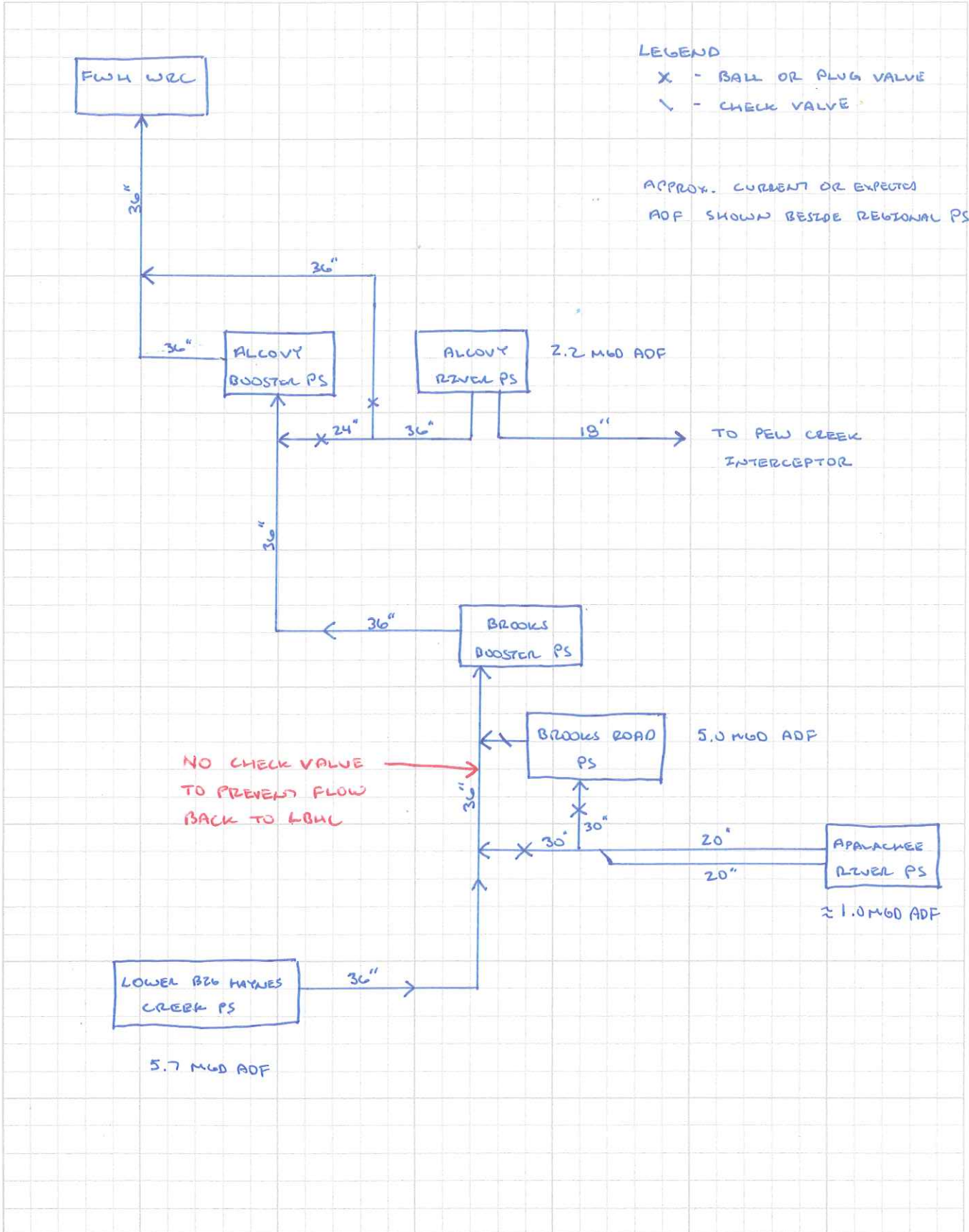
