**Addendum #2  
BL122-25  
Uniform Rental and Laundering Services on an Annual Contract**

Please see the below summation of questions and answers for the above-mentioned bid.

**PLEASE DELETE PAGES 10-16 AND REPLACE WITH THE REVISED BID SCHEDULE PAGES 10R-16R.**

**OPENING DATE WILL BE POSTPONED UNTIL FURTHER NOTICE.**

Q1: Is a Bid/Surety Bond required for BL122-25?

**A1: No, a Bid/Surety Bond is not required for BL122-25.**

Q2: In the event that an Addendum is delayed, will Gwinnett County consider a bid deadline that is 5 business days following the "Answer" portion being posted?

**A2: Yes, a new bid deadline will be included in the next addendum.**

Q3: Would the County consider adding the following language? "In the event that the needs of any department change, a different item may be selected and added to this contract at a similar discount structure."

**A3: Yes, but different item must be equivalent to replaced item.**

Q4: For Carhartt, Red Kap, and all garments, is it required that they all be tested or classified as Industrial Launderable?

**A4: Awarded vendor will be responsible to ensure requested garments are laundered and otherwise cared for in accordance with any relevant regulations.**

Q5: If the vendor identifies an opportunity for an alternative garment to better meet the needs of the department, can those samples be presented to the department at the sample review meeting?

**A5: Yes, those samples may be reviewed at the sample review meeting.**

Q6: Can clarification be made if an embroidered emblem with a color match background will be used as the logo for all rental garments? If yes, can a supplier provide an emblem sample(s) in the bid packet?

**A6: All shirts must have embroidered emblem.**

Q7: In all cases can "pressed" be replaced with "pressed or steam tunnel finished" as outlined by Dept of Water Resources on Page 8?

**A7: Yes**

Q8: On page 4 under Uniform Rental Service Section #9, would Gwinnett County consider the removal of this section? This is addressed in section 12 and also not applicable to "all" garments as stated in section #9. All garment repairs will be to NFPA standards with FR threads and like material patching.

**A8: Yes**

Q9: Would Gwinnett County consider the removal of the following portion of Section H on page 29 as it does not apply to this contract, it is not a construction project?

"H. Gwinnett County is exempt from federal excise tax and Georgia sales tax regarding goods and services purchased directly by Gwinnett County. Vendors are responsible for federal excise tax and sales tax, including taxes for materials incorporated in county construction projects. Vendors should contact the

State of Georgia Sales Tax Division for additional information. Agreements were there is a cost-plus mark-up, mark-up will not be paid on taxes.”

**A9: No, this is standard language and will not be removed, but it does not apply to this contract.**

Q10: Would Gwinnett County consider the following revision on page 32 under the Section titled XVII.

**DEFAULT?**

The contract may be canceled or annulled by the Purchasing Director in whole or in part by written notice of default to the vendor upon non-performance or violation of contract terms; provided that, vendor is first provided written notice of any such non-performance and/or violation of contract terms and a reasonable opportunity to cure the same. An award may be made to the next low responsive and responsible vendor, or the next highest scoring responsive and responsible proposer, or articles specified may be purchased on the open market similar to those so terminated. In either event, the defaulting vendor (or their surety) shall be liable to the County for costs to the County in excess of the defaulted contract prices; provided, however, that the vendor shall continue the performance of this contract to the extent not terminated under the provisions of this clause. Failure of the vendor to deliver materials or services within the time stipulated on their offer, unless extended in writing by the Purchasing Director, shall constitute contract default.

**A10: No, this is standard language and will not be removed.**

Q11: Would Gwinnett County consider the following revision on page 33 under the Section titled XVIII.

**TERMINATION FOR CAUSE?**

The County may terminate this agreement for cause upon ten days prior written notice to the vendor of the vendor's default in the performance of any term of this agreement; provided that, vendor is first provided written notice of any such default and a reasonable opportunity to cure the same. Such termination shall be without prejudice to any of the County's rights or remedies by law.

**A11: No, this is standard language and will not be removed.**

Q12: Would Gwinnett County consider the following revisions on page 33 under the Section titled XXXII.

**INDEMNIFICATION?**

To the fullest extent permitted by law, the vendor shall, at his sole cost and expense, indemnify, defend, satisfy all judgments, and hold harmless the County, its commissioners, officers, agents, and employees (the "County Parties") from and against all claims, damages, actions, judgments, costs, penalties, liabilities, losses and expenses, including, but not limited to, attorney's fees arising out of or resulting from the performance of the work, provided that any such claim, damage, action, judgment, cost, penalty, liability, loss or expense (1) is attributable to bodily injury, sickness, disease, or death, or to injury to or destruction of tangible property (other than the work itself) including the loss of use resulting therefrom, and (2) is to the extent caused in whole or in part by the negligent acts, errors by any negligent act or negligent omission of the vendor, any subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be are liable, regardless whether such claim is caused in part by a party indemnified hereunder. Vendor's obligations under this Section shall not apply to the extent of any negligence, willful misconduct, violation of law, and/or breach of this Agreement by any of the County Parties. Such obligation shall not be construed to negate, abridge, or otherwise reduce any of the rights or obligations of indemnity which would otherwise exist as to any party or person described in this agreement. In any and all claims against the County, its commissioners, officers, agents, and employees by any employee of the vendor, any subcontractor, anyone directly or indirectly employed by any of them, or anyone for whose acts any of them may be are liable, the indemnification obligation contained herein shall not be limited in any way by any limitation on the amount or type of damages, compensation, or benefits payable by or for the vendor or any subcontractor under Worker's Compensation Acts, disability benefit acts, or other employee benefit acts.

**A12: No, this is standard language and will not be removed.**

Q12: Is the lined jacked requested by Support Services the only outerwear requested?

**A12: Yes**
