The Gwinnett County Board of Commissioners is soliciting competitive sealed proposals from service providers for the **Provision of a Voluntary Benefits Program on a Multi-Year Contract** for the Department of Human Resources.

Proposals must be returned in a sealed container marked on the outside with the Request for Proposal number and Company Name. Proposals will be received until **2:50 P.M. local time on October 30, 2025** at the Gwinnett County Financial Services - Purchasing Division – **4th Floor Charlotte J. Nash Building, 75 Langley Drive, Lawrenceville, Georgia 30046. NOTE THAT THE PURCHASING DIVISION HAS TEMPORARILY RELOCATED. ALL PROPOSALS MUST BE SUBMITTED AT THIS LOCATION. Any proposal received after this date and time will not be accepted. Cost proposals should be submitted in a separate sealed envelope.** Proposals will be publicly opened and only names of submitting service providers will be read at 3:00 P.M. local time. A list of service providers submitting proposals will be available the following business day on our website GwinnettCounty.com.

Questions can be submitted at any time leading up to this deadline and service providers are encouraged to ask questions early. Proposals are legal and binding upon the service provider when submitted. Two unbound single-sided copies (one marked original and one marked copy), and five digital (flash drive) copies (three technical and two financial) should be submitted.

Successful service providers will be required to meet insurance requirements. The Insurance Company should be authorized to do business in Georgia by the Georgia Insurance Department and must have an A.M. Best rating of A-7 or higher.

Gwinnett County does not discriminate on the basis of disability in the admission or access to its programs or activities.
