Q1. Can Gwinnett please provide specific part numbers for hardware requested?  
**A1. Ultra7 16GB RAM and 256GB SSD, SKU = EP2-14797 for the tablets and 8X8-00164 for the keyboard/cases.**

Q2. Apple confirmed that they do not offer AppleCare terms of the length requested in the bid specs. How would Gwinnett like these quoted?  
The available options are:

- AppleCare+ for Mac: 3 years
- AppleCare+ for iPad: 2 years

**A2. This is acceptable.**

Q3. For Section C – Apple: Does Gwinnett want AppleCare included in the cost listed in the minimum requirements? The MSRP does not include the additional AppleCare cost.
