ARTICLE 1 – ADDENDUM

1.01 Amend the Contract Documents

- A. Make the additions, modifications, or deletions to the Contract Documents described in this Addendum.

1.02 Acknowledge Addenda

- A. Acknowledge receipt of this Addendum in the Bid Form submitted for this Project. Failure to acknowledge receipt of this addendum in the Bid Form may render the Bid as non-responsive and serve as the basis for rejecting the Bid.

ARTICLE 2 – BID REQUIREMENTS

2.01 Section 00 41 16 “Bid Form Exhibit A”

- A. Delete Section 00 41 16 “Bid Form Exhibit A” in Addendum 02 and replace it with Section 00 41 16R2 “Bid Form Exhibit A” included with this Addendum. Submit only the revised form with the Bid.

ARTICLE 6 – QUESTIONS

- 6.01 Please provide clarification for bidding purposes regarding the tapping sleeve size shown in the contract documents. 2" × 2" tapping sleeve is not manufactured; however, a 2" × 1½" tapping sleeve is available. Please confirm whether it is acceptable to bid a 2" × 1½" tapping sleeve in lieu of the 2" × 2" indicated or advise if an alternative configuration is required.
- A. This connection will be done by a cut in connection to the existing 2" line with a 2" tee (PVC). Please see the updated C-101 drawing attached.
- 6.02 Please provide a copy of the plan holders list.
- A. The plan holders list can be provided upon request from Ashley.Campbell@TetraTech.com and/or Caleb.Gulmire@TetraTech.com at any time.
- 6.03 12" isolation valves are shown on the plans yet there is no pay item. How will this be paid for?
- A. All 12" valves should be gate valves and paid for under item BB-16.
- 6.04 Remove fire hydrants and relocate valve monuments are called out on the plan. What items are these supposed to be under?
- A. This should be included under item BB-13.
- 6.05 Is the class A item specifically for the trench repair? Is the concrete for thrust blocking to go under the water line items?
- A. This is correct. BB-03 is associated with trench repair. As per M&P item 29, all concrete for thrust restraint should be included under the water line items (BB-13, BB-14, and BB-15).
- 6.06 Does this project require domestic products only?
- A. All products that meet the specifications outlined in the bid package will be acceptable.
- 6.07 Are there any specific lane closure restrictions that contractors would need to follow?
- A. Yes, one (1) travel lane should be maintained at all times.
- 6.08 Are portable signs allowed on this project?
- A. Yes, this is allowable. All sign placements are to follow MUTCD standards.
- 6.09 It was noticed that the plans call for polywrap in certain locations. Are any detector tape and/or tracer wire required for this project?
- A. No, detector tape and/or tracer wire is not required for this project.

- 6.10 Who's responsible for the Geotech testing for quality assurance?
- A. The Owner (Gwinnett County Department of Water Resources, GCDWR) will provide for quality assurance testing. The contractor is required to meet all quality standards outlined in the bid package. It is the contractor's responsibility to rectify any deficiencies found by GCDWR quality assurance testing.
- 6.11 The general notes state all service lines are 2", but the plans state all services are ¾". Please provide clarification on which is correct.
- A. Service connections are to be ¾".
- 6.12 Please provide the Pre-Bid sign-in sheet.
- A. Please see the attached Pre-Bid sign-in sheet.
- 6.13 The South Scales Road Water Main Plans are calling out for a 10x8 Tap Sleeve and Valve on page C-106. Will this be added to the bid form?
- A. BB-21 (originally a 2-inch X 2-inch tapping sleeve and valve) has been removed as per 6.01 above. This item has now been changed to accommodate the 10-inch X 8-inch tapping sleeve and valve.
- 6.14 Is item BB-21 only for relocating the meter and the service line installation/tap to be paid for under BB-22 or BB-23?
- A. BB item for "Relocated Existing Water Service Meter" (BB-22 in this addendum) covers the relocation of the meter and "Water Service Short Side" and "Water Service Long Side" (BB-23 and BB-24 in this addendum) covers the tap to the water main. See 01 29 01 for additional information.

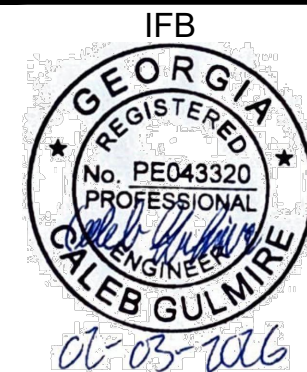
