- R2.** **Please REMOVE Specifications, Item 9. to;** Gwinnett County reserves the right to make multiple awards, utilizing the vendor(s) based on cost and availability.
- R3.** **Please REVISE Specifications, Item 11. to;** Gwinnett County reserves the right to cancel any scheduled hauling services due to unforeseen events (weather, etc.). Should a service provider arrive on site for scheduled services and the County cancels, due to no fault of the service provider, the awarded service provider may bill for a maximum of two hours at the contracted hourly rate. If the service provider is on site for more than two hours prior to County cancellation, the service provider shall bill for actual hours on site. Service providers are responsible for arriving with appropriate trucks and equipment for scheduled services.
- R3.** **Please REVISE Specifications, Item 13. to;** Awarded vendor(s) shall provide the County with hauling tickets from pick-up and/or drop off locations within 48 hours of hauling. The awarded vendor is required to use the most direct truck route for each job to avoid unnecessary billable hours/cost to the County. All billable hours are subject to County verification and approval.
- R4.** **Please ADD Item 14 to the Specifications;** This contract is used to supplement County labor and equipment. The County reserves the right to use County resources when available for these services.
