CLARIFICATIONS:

C1. The concrete pad shall be completed first. This shall be coordinated with the Gwinnett County project manager.

QUESTIONS & ANSWERS:

Q1. There are parking spaces along the fence in the enclosed parking area that are missing wheel stops. Are we to add wheel stops in these spaces?

A2. Yes, missing wheel stops must be added only in spaces along the fence.

Q2. Do damaged wheel stops need to be replaced?

A2. Yes, any wheel stop that is damaged must be replaced.

Q3. For the curbs at the pavilion: Are the curbs on both sides of the fuel pump to be replaced? Or just the two curbs, both on the same side, and in the drawing?

A3. All yellow painted curbs on both sides under the fuel station canopy must be replaced.

Q4. Are there any restrictions on working hours?

A4. No.
