The Gwinnett County Board of Commissioners is soliciting competitive sealed bids from qualified Contractors for the **McDaniel Farm Park to Satellite Boulevard Pedestrian Improvement Project** for the Department of Transportation.

Bids should be typed or submitted in ink and returned in a sealed container marked on the outside with the BL098-26# and Company Name. Bids will be received until **2:50 P.M. local time on July 23, 2026** at the **Gwinnett County Financial Services - Purchasing Division – 2nd Floor, 75 Langley Drive, Lawrenceville, Georgia 30046**. Any bid received after this date and time will not be accepted. Bids will be publicly opened and read at 3:00 P.M. Attendance for the opening is optional and will be **VIRTUAL ONLY**. An on site pre-bid conference is scheduled for **10:00 a.m. on Wednesday, July 1, 2026**, Atlas Office, 2450 Commerce Ave N.W., Duluth, GA 30096. Participants will park at the Office and walk to where Boardwalk worksite will linkup on Commerce Ave. Any change to meeting will be sent to all Plan Holders via e-mail prior to the meeting. All consultants are urged to attend.

This Pedestrian Improvement project/contract consists of 0.813 miles of clearing & grubbing, grading, sidewalk and trail construction, a pedestrian bridge, curb & gutter, storm drainage installation, asphalt resurfacing & striping, signal upgrades, and landscaping. The project will upgrade the southbound Commerce Avenue sidewalk and connect to the existing McDaniel Farm Park trail network.

All vendors must submit with bid, a bid bond, certified check, or cashier's check in the amount of five percent (5%) of the total bid. **Failure to submit a bid bond with the proper rating will result in the bid being deemed non-responsive.** Successful vendors will be required to meet insurance requirements, submit a one hundred percent (100%) performance bond and a one hundred percent (100%) payment bond. Insurance and Bonding Company should be licensed to do business by the Georgia Secretary of State, authorized to do business in Georgia by The Georgia Insurance Department, listed in the Department of Treasury's Publication of Companies holding Certificates of Authority as Acceptable Surety on Federal Bonds and as acceptable reinsuring companies. **The bid bond, payment bond, and performance bond must have an A.M. Best rating of A-8 or higher.**

Gwinnett County does not discriminate on the basis of disability in the admission or access to its programs or activities. Gwinnett County reserves the option to negotiate terms, conditions and pricing with the lowest responsive, responsible vendor(s) at its discretion.
