FEE SCHEDULE

RATE EFFECTIVE JULY 15, 2022

SITE DEVELOPMENT PERMIT

Fees are due at time of site plan approval.

1. **T.V. INSPECTION FEE:** \$45.00 plus \$0.30 per linear foot of 8" or larger sewer pipe and or 18" or larger storm pipe. **NOTE:** Additional fees for TV inspection will be required if approved in more than one phase or unit. This fee will be collected at the time of re-approval. If a re-inspection fee is necessary, the additional inspection fees will be collected after TV Inspection is completed.
2. **NEW STUB OFF EXISTING SEWER LINE :** \$550.00

BUILDING PERMIT

Meter fees are due at time of building plan approval, prior to issuance of building permit. Fees are determined by the size of water meter required for the project.
